

#### Dangers aside, drugmakers can't live without Chinese APIs

When it comes Chinese-made APIs, Western drugmakers are between a rock and a hard place. They know Chinese oversight of bulk APIs is insufficient to snuff out substandard producers, but since China produces more APIs than any other country, they can't live without them.



"If China for some reason decided to stop exporting APIs, within three months all our pharmacies would be empty," Guy Villax, CEO of Hovione, tells *Reuters*. The Portuguese API supplier has factories in China, as well as the U.S. and Ireland.





After 80 U.S. patient deaths were tied to tainted Chinese heparin in 2008, Chinese authorities pledged to crack down on API suppliers. But a *Reuters* investigation finds that while China is doing more, the fact that many Chinese APIs are substandard or counterfeit is an open secret. "Illegal ingredients in bulk are a big problem, but nobody talks about it," Villax says.


Dear Secretary Esper:


We write to request information regarding the national security risks posed by the role of foreign manufacturing in the pharmaceutical products supply chain. Millions of Americans, including servicemembers, rely on drugs to stay healthy—yet the United States imports a significant portion of these drugs' components from China.<sup>1</sup>

In light of a recent report from the U.S.-China Economic and Security Review Commission (Commission) highlighting the nation's "growing reliance" on drug products made in China, it is critical that DoD, along with other key federal agencies, address the dangers posed by U.S. reliance on foreign drug makers.<sup>2</sup>

### India Depends on China for 69% of Raw Materials/Chemicals to Make Generic Drugs

India's generic industry depends on China for 69% of the raw material and chemical intermediates to make Active Pharmaceutical Ingredients (India Directorate of Commercial Intelligence and Statistics)

## Case Study: Closure of Last U.S. Penicillin Plant

The U.S. can no longer make penicillin

The last U.S. penicillin plant closed in 2004.


Why? China's penicillin cartel.

China's cartels fix prices and control supply + government subsidies, currency manipulation, etc.



Penicillin Market Price vs. Global Market Share of Chinese Penicillin: Chinese market share vs. annual price average





Chinese inroad: After several years of having put extreme downward pressure on prices (through dumping via India) a sharp price increase starts after a critically dominant world market share has been obtained by China. 7

## **Last US Penicillin Industrial Capability**

The last penicillin plant was a Bristol Myers Squibb capability that once made 70% of raw material (fermentation)



 Closure = demolishing
50 buildings = loss of industrial base/security (Syracuse.com)
